NOTICE OF PUBLIC HEARING AND PUBLIC COMMENT PERIOD FOR THE CITY OF TEMECULA 2020-2021 CDBG ACTION PLAN

Pursuant to the United States Department of Housing and Urban Development (HUD) regulations, the City of Temecula has prepared a 2020-2021 Action Plan.

The 2020-2021 Action Plan is the City's application to HUD for Community Development Block Grant (CDBG) funds delineating the projects to be undertaken during the program year. The Action Plan identifies the federal and other resources expected to be used to address the priority needs and goals noted in the City's Five-Year Consolidated Plan (2017-2021) adopted by the City in 2017. The City anticipates receiving approximately \$559,529 in CDBG funds during 2020-2021.
