A PUBLIC HEARING has been scheduled before the **CITY COUNCIL, TEMECULA COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS, and the SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY BOARD OF DIRECTORS** to consider the matter(s) described below.

The Temecula Community Services District (TCSD) operates under the authority of the Community Services District Law and provides street lighting, perimeter landscaping and slope maintenance, street and road improvements and maintenance, and refuse collections services in the City of Temecula. The boundaries of the TCSD are the same as those of the City of Temecula, and the City Council also serves as the Board of Directors of TCSD (TCSD Board).

The Capital Improvement Program operates under the authority of the City Council, the TCSD Board and the Successor Agency to the Redevelopment Agency Board of Directors (SARDA Board).

On Tuesday, June 9, 2020, at 7:00 p.m., or as soon thereafter as practicable the City Council, TCSD Board and SARDA Board will hold a joint public hearing on the adoption of the Proposed TCSD Fiscal Year 2020-21 Operating Budget (Budget) and the Proposed Fiscal Years 2021-25 Capital Improvement Program (CIP)
